Background



Human rights education (HRE) is a human right in itself, as recognised in international law¹. Human rights education develops the knowledge, skills, and attitudes needed to protect and promote human rights in daily life.

UN fora have highlighted that higher education institutions, through their core functions (research, teaching, and service to the community), have the social responsibility to educate Manfred Nowak, GC Secretary General ethical citizens committed to the construction of peace, the defence of human rights, and the values of democracy². Yet, out of the about 30,000 universities worldwide, a mere fraction offers human rights courses.

Chiara Adamo, Head of Unit Gender Equality, Human Rights and Democratic Governance at the European Commission Directorate General for International Partnerships (DG INTPA). Since joining the Commission, in 2000, she has been working in the Justice and Home Affairs area, as head of sector in charge of inter-institutional relations (European Parliament, Council, CdR and EESC) in the Justice and Home Affairs Directorate General.



Farida Shaheed was appointed UN Special Rapporteur on the Right to Education in 2022. She is the Executive Director of Pakistan's leading gender justice organisation, Shirkat Gah - Women's Resource Centre. She served as a member of Pakistan's National Commission on the Status of Women, and as the first Special Rapporteur in the field of cultural rights from 2009 to 2015.



Manfred Nowak, Secretary General of the Global Campus of Human Rights, is a longstanding Professor of Human Rights and Director of the Vienna Master of Arts in Applied Human Rights at the University of Applied Arts. He has served as the UN expert on enforced disappearances, torture, and as an Independent Expert leading the UN Global Study on Children Deprived of Liberty. Prof. Nowak has published over 600 publications in public and international law and human rights.



George Ulrich, Academic Director of the Global Campus of Human Rights, is a senior human rights scholar and has held various positions at the GC, including Programme Director, Secretary General and Academic Coordinator, In between these appointments, he held the position of Rector and Professor of Human Rights at the Riga Graduate School of Law. Prof. Ulrich's research interests include human rights history, development cooperation, health, and ethics.



Felisa Tibbitts is a renowned human rights education expert, currently UNESCO Chair in Human Rights and Higher Education and Chair in Human Rights Education, Utrecht University (Netherlands), as well as Adjunct Assistant Professor at Columbia University. She has extensively published on curriculum policy, critical pedagogy, education and social movements, and human rights and higher education transformation. She has also co-founded the NGO Human Rights Education Associates (HREA) and has held adjunct faculty positions at Harvard and Nelson Mandela University.



Mike Hayes, Director of the GC Asia-Pacific Programme, he is a senior scholar at the Institute for Human Rights and Peace Studies at Mahidol University, specialises in non-citizen rights and human rights and migration. He offers professional training in the Rights Based Approach and human rights advocacy. Hayes also works on developing Southeast Asian lecturers' capacity to teach and research human rights, including the PhD and regional master's programs.

Eduardo Kapapelo, is a Researcher, and the Project Coordinator of the Nelson Mandela World Human Rights Moot Court Competition which is organised by the Centre for Human Rights at the University of Pretoria. With a focus on a variety of critical topics, Eduardo is currently working on issues relating to climate justice and human rights.



Elena Ippoliti coordinates the Human Rights Education and Training Unit of the Methodology, Education and Training Section at the Office of the United Nations High Commissioner for Human Rights in Geneva. Her responsibilities include designing and organising human rights training programmes, developing educational materials and assisting United Nations initiatives in the area of human rights education, in cooperation or partnership with governmental and civil society actors.
